## The Bermuda Triangle

Many people believe that the Bermuda Triangle is one of the most supernatural places on earth. Let's explore why this hub of ocean mysteries may have earned such a scary reputation.

## Where Is the Bermuda Triangle?

The Bermuda Triangle is not a set place: it is an area of the Atlantic Ocean between 500,000 $1,510,000$ square miles in size. It can be found between the coasts of Florida, Puerto Rico and the island of Bermuda. This hot spot of activity regularly sees a many ships and aircrafts travelling through it.


## Why Is the Bermuda Triangle so Famous?



Stories of strange activity within the Bermuda Triangle date back hundreds of years. Some of the earliest are the stories told by Christopher Columbus and his crew.

During his first journey across the Atlantic Ocean in 1492, Columbus reported many strange sightings within the Bermuda Triangle. The first of these was that the stars appeared to move around in the sky. Another was that Columbus saw a light (like that of a candle) moving up and down in the distance. When he asked his crew to look at the light, it vanished and reappeared many times.

The most unusual thing that Columbus says that he saw was a glowing object coming out of the water and shooting towards the sky. Many people think that this must have been a light on the shore or from another ship. However, some people believe that Columbus saw a UFO.

## Did You Know...?

Two 14-year-old boys boarded a small boat to go fishing in July 2015. Although their boat was found off the coast of Bermuda one year later, the boys were never seen again.


## What Strange Things Are Said to Have Happened?

Lots of strange events are said to have happened within the Bermuda Triangle, such as:

The Ellen Austin was a large cargo ship. The crew onboard found a small boat drifting along within the Bermuda Triangle. They decided that it had been abandoned. Captain Baker ordered four members of his crew to board the boat and sail it to New York. On the third day of sailing, the crew were said to disappear from the boat. When Captain Baker ordered a new crew to board the small boat, they disappeared too.

> A US Navy ship called the USS Cyclops set off on a journey from Brazil to Baltimore, USA. The ship was almost 170 metres long and had a crew of 306 sailors aboard. On the ninth day of the ship's journey, it vanished and it has never been seen or heard from again.


Twelve members of the US Navy boarded a seaplane and left Florida in July of 1945. After sending their radio position at 1:16 a.m., the plane disappeared. Despite a ten-day search, neither the plane nor its crew were ever found.

## Glossary

cargo: Goods that are carried on a ship, aircraft or motor vehicle.
Christopher Columbus: An Italian explorer and navigator.
seaplane: An aircraft with floats or skis instead of wheels. It can land on and take off from water.
supernatural: Something that is beyond scientific understanding.
UFO: An Unidentified Flying Object. A mysterious object seen in the sky that there is no known explanation for.

While many modern-day investigators try to explain this away (as lights on distant shores or the distress call of another ship), many others think that the crew encountered UFOs. They continue to use Columbus's story as proof of alien activity within the Bermuda Triangle.

When he summoned his crew to look at the light, it vanished and reappeared multiple times before their eyes.

In the most bizarre and famous account of strange activity given by Columbus, he told of how a glowing, disc-shaped object emerged from the water and seemed to shoot towards the sky. While many modern-day investigators try to rationalise Columbus's accounts as merely lights on distant shores or the distress call of another ship, many others speculate that the crew of the Santa Maria encountered UFOs of alien origins and continue to use Columbus's narrative as proof of supernatural activity within the Bermuda Triangle.

Pupils' own responses, such as: The disappearance of Frank and Romina Leone is similar to the disappearance of Austin Stephanos and Perry Cohen because, in both instances, the parties set out on their boats to go fishing and both trips resulted in the people aboard disappearing.
